VHA Mandatory Training for Trainees

In order for you to train at the VA, you are required to complete a mandatory training program titled **VHA Mandatory Training for Trainees**. This training is available through the VA Talent Management System (TMS). The TMS offers web-based training to VA employees and its partners.

To use the TMS, you must self-enroll and create a profile at <http://www.tms.va.gov>. Follow the steps listed below to create your profile, launch the mandatory training course and complete the training module. Important, if you do not complete this training requirement prior to your scheduled orientation, you WILL NOT be fingerprinted and will not be able to begin your professions training at the VA.

1.1 Step-by-Step Instructions

From a computer, launch a web browser and navigate to <http://www.tms.va.gov>

1. Click the [**Check System**] link located in the **brown bar** under the SIGN IN button. If one of the computer components is not compatible with TMS requirements, then a red “x” will appear next to the **Check System** link. Follow the instructions to bring your computer up to the TMS standards.
2. Click the [**Create New User**] link located next to Check System.
3. Select the radio button for [**Health Professions Trainee**].
4. Click the [**Next**] button and complete all fields.

- iii. VA Location Code – use drop-down box **HUN** (*Huntington VA Medical Center*)
- iv. Trainee Type – use drop-down box (**All other Health Professionals**)
- v. Specialty/Discipline – use drop-down box (**Other**)
- vi. VA Point of Contact First Name - type **Raymond**
- vii. VA Point of Contact Last Name - type **Rideout**
- viii. VA Point of Contact Email – type **Raymond.rideout2@va.gov**

Once you have entered all of the required data, click the [**Submit**] button. Your **UserID** will be displayed on the confirmation page. To begin your training, click the [**Continue**] button and wait until your [**To-Do-List**] list is displayed with the title of the mandatory training course.

1.2 Launching and Completing the Content

1. Place the mouse over the title “**VHA Mandatory Training for Trainees**”.
2. Click [**Go to Content**] button in the pop-up window that appears.
3. Begin the course training following the on-screen instructions.
4. When the training is completed, you will be instructed to click [**EXIT**] located at the top right portion inside the training module. You have now completed your mandatory training.
5. **IMPORTANT:** Click on the [**Completed Work**] located in a pod at the lower right side of your internet browser window to verify your training has been recorded in TMS.
