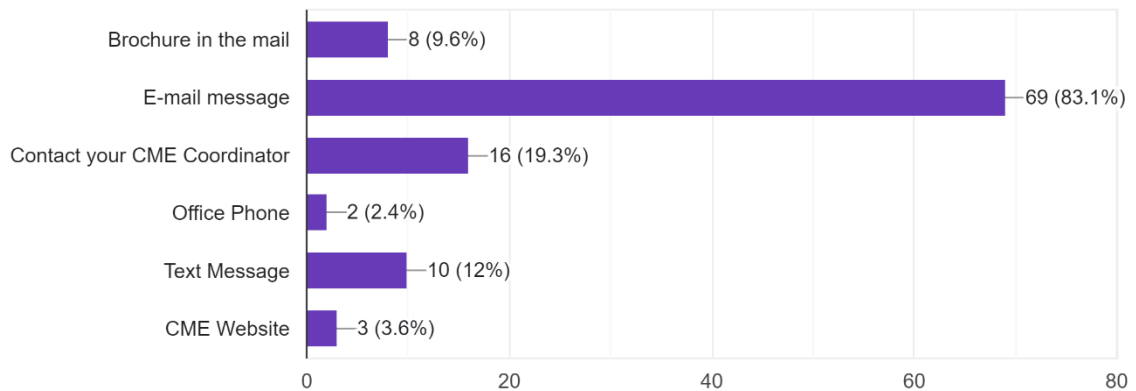

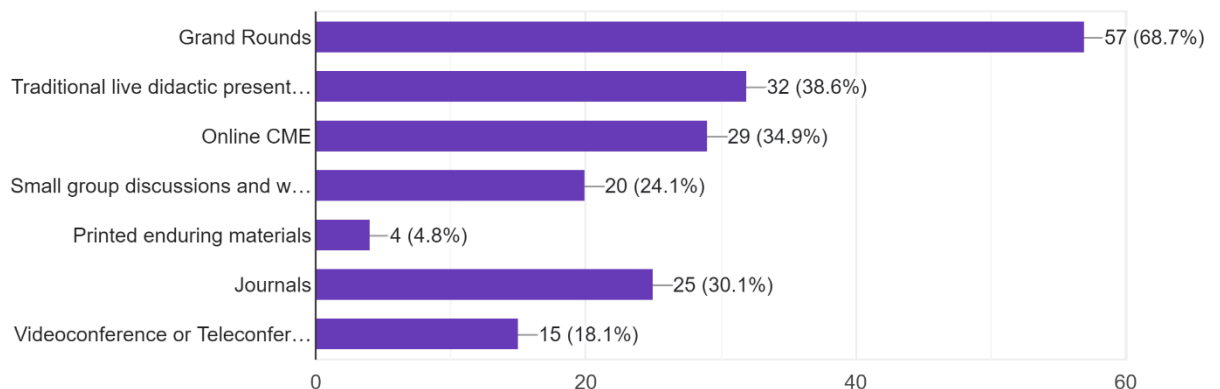
1. What is the best way for CME to communicate with you regarding future CME activities that might interest you?

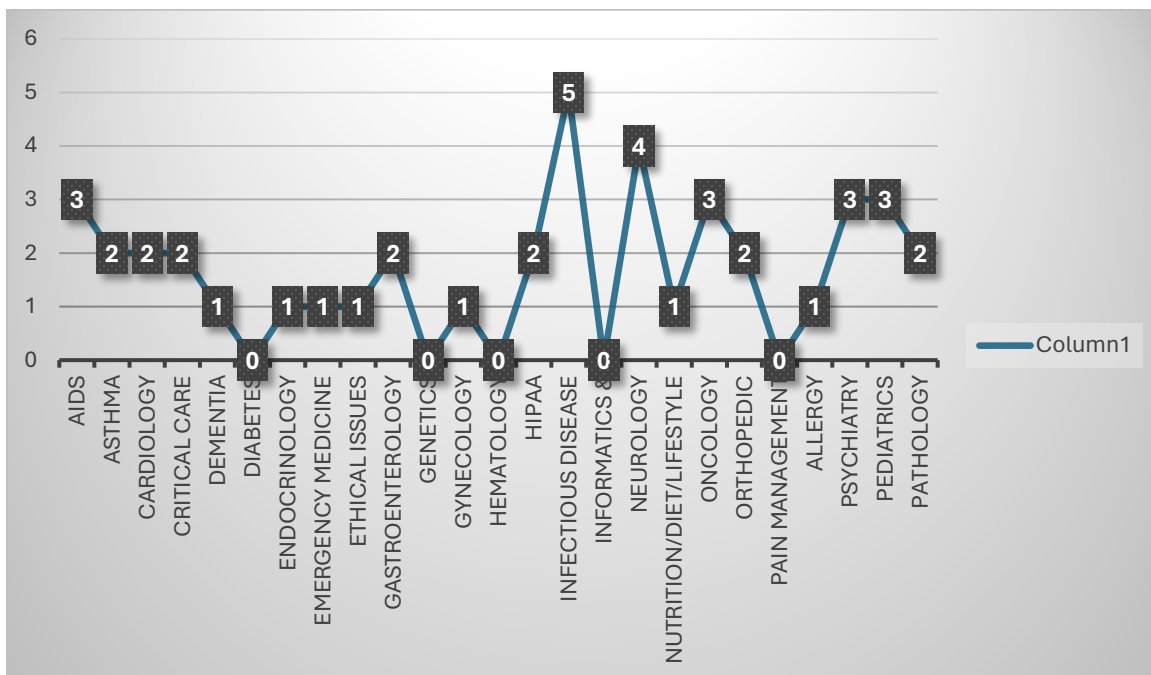

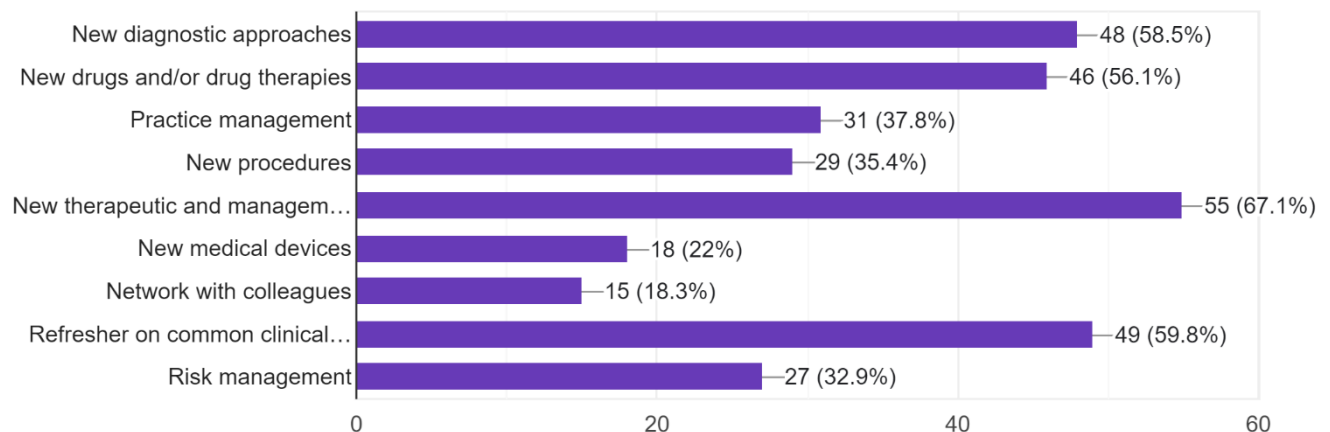

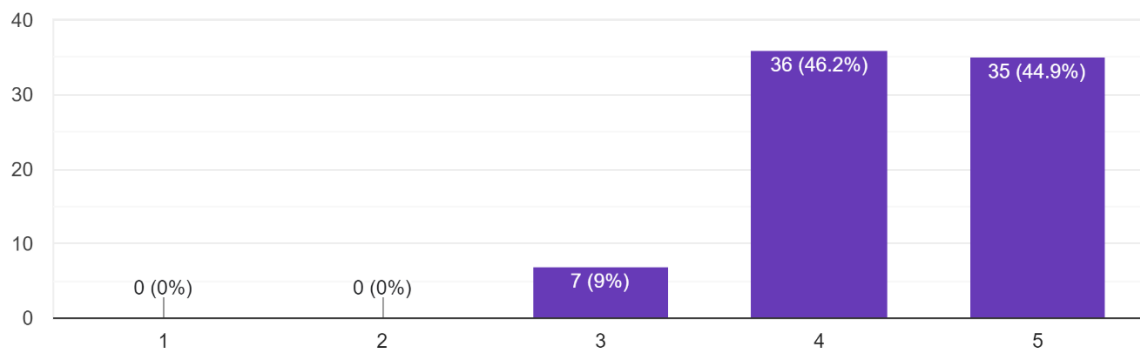

Knowledge: On a scale 1 to 5, 1 being the lowest, did you feel that attending the CME activities this year helped you gain knowledge from the learning objectives provided?

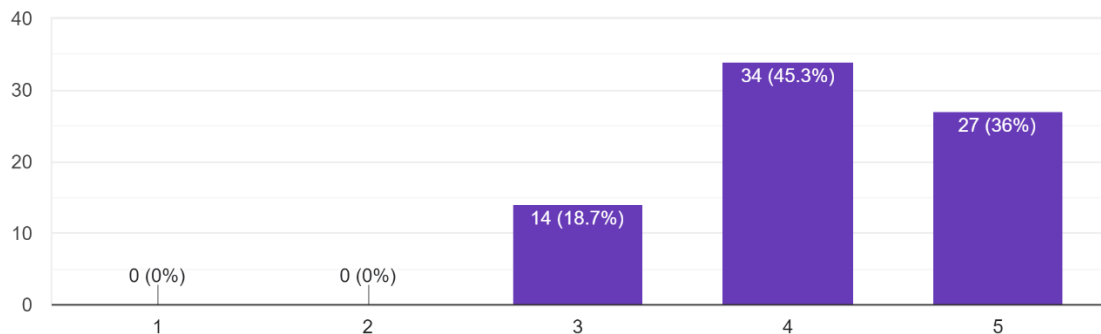

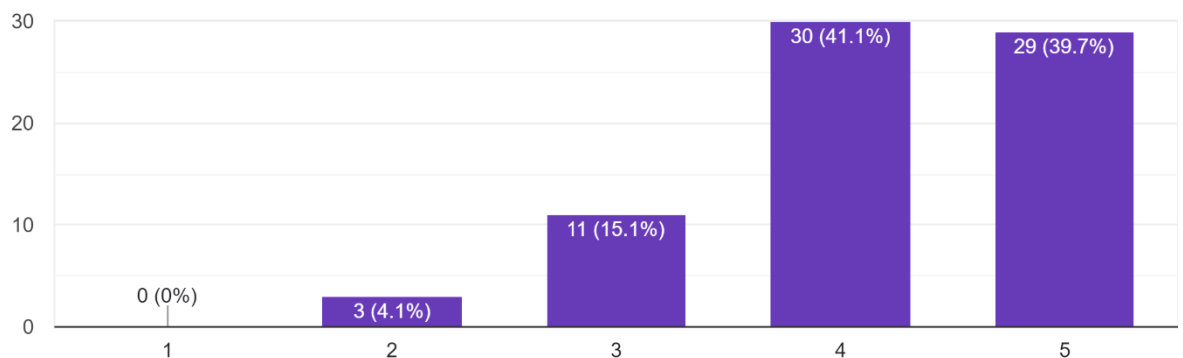

Performance: On a scale 1 to 5, 1 being the lowest, how do you rate the performance you provided to the patient that you learned from the CME activity?

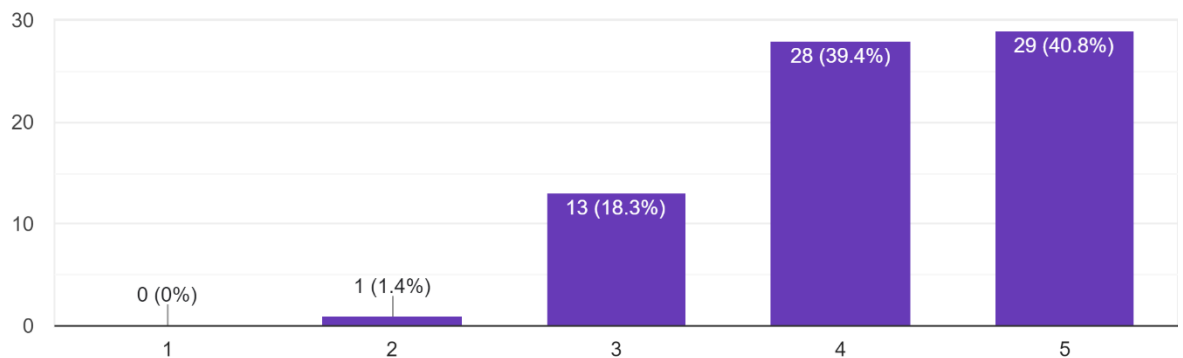

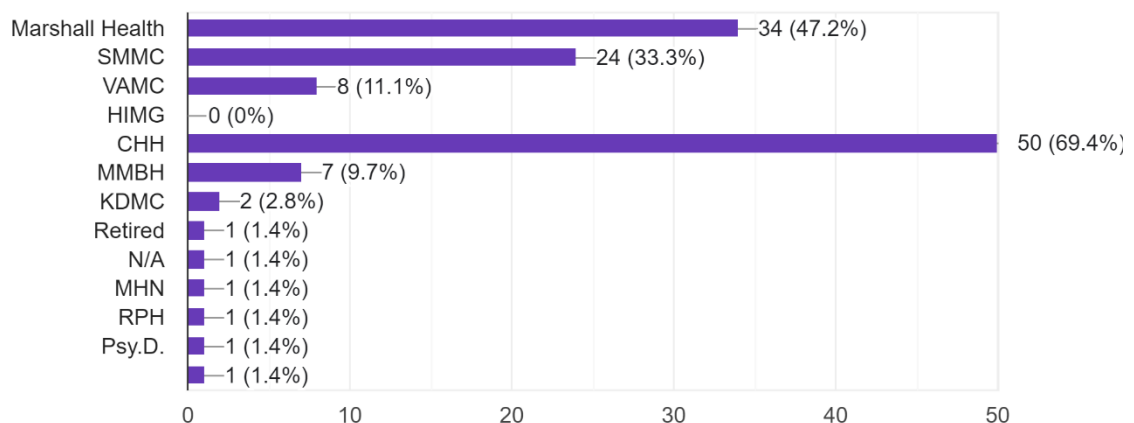
### Where are you licensed?
