New Initiatives Corner

The Academic and Professionalism Standards Committee (APSC) has been busy updating its policies to incorporate many changes that have been made over the last year or two concerning clerkship assessments, the creation of the new office of academic support and clarifying the roles and process of remediation. All of these changes are in line with staying up to date with curricular changes and assisting struggling students as much as possible.

Dr. Canterbury, the Vice Dean of Medical Education from the University of Virginia visited our medical school and spoke with the MS1 and MS2 biomedical science faculty and the Curriculum Committee in December of 2016. The nature of his talk and discussions was the transition from a full two year pre-clinical program to a shorter term curriculum. He walked us through the planning and implementation that occurred and the issues one needs to think carefully about. We are currently in the process of looking at our two year curriculum to see if 1) it can be shortened, 2) it can be further integrated and/or 3) the pedagogy can be improved.

The JCESOM curriculum committee is one of the most important committees that implements curricular change at the medical school. As the structure of our basic science departments have recently changed, a review of the bylaws and operating procedures was undertaken. After extensive discussion, the composition of members will be revised to accommodate the new changes in department structures and a move towards electing members of the committee. The newly elected committee will be in effect July 1st. Each clinical and basic science department will begin electing voting members to the committee soon.
