RESPONSIBILITIES

- Working under limited supervision the person in this position will facilitate the Cremation Permit process, Inquiry Sign-Out process and Death Certificate Quality Control process for the Office of the Chief Medical Examiner
- Performs medical record review for determination of competency of death certificate completion, gathering
 information and facts for approval by forensic pathologist as necessary
- Performs medical record and death certificate review in order to establish that the death certificate and case information meet criterion for issuance of a cremation permit
- Performs medical record review for cases not properly presented to the OCME for triage at time of death in order to provide narrative circumstances for determination of case type and any requirements for determination of cause and manner of death by a forensic pathologist in a particular case
- Provide on-call consultation services to the Forensic Investigations Unit as assigned
- Assist forensic pathologists as needed in the performance of medicolegal investigations
- Assist OCME Administrator as needed
- Other duties as assigned.

QUALIFICATIONS

- Successful completion of an accredited physician's assistant program.
- Board certified to practice in WV
- Two to five years of experience with a medical practice setting where diagnosis, treatment and patient education were the main focus of the role.
- Experience in pathology preferred.
- Ability to maintain professionalism in the face of difficult situations.
- Highly detail oriented, works well within a diverse team, demonstrates a high degree of initiative and
 flexibility, able to communicate effectively in a positive and professional manner, able to prioritize activities
 when under tight deadlines, and possesses analytical skills.
- Strong technical skills including word processing, spreadsheet development and management, and database management, with a particular emphasis on proficiency in Microsoft Office Suite.
