The new rural residents will complete at least fifty percent of their training at Logan Regional Medical Center (LRMC) with Dr. Cisco-Goff and Dr. James Paugh with the remaining time in Huntington and a transplant month in Lexington, Kentucky. The program is sponsored by the Marshall Community Health Consortium.

Resident Wellness and Well-being


